However, the Club also exists for its adult members and activities often proceed on an informal basis with each individual having made their own assessment of whether they are happy with the level of ability required. In the case of members who are under 18 years of age we require that parents or guardians take responsibility for ensuring that they are fully informed of the nature of the activity and the level of safety cover (both on and off the water) each time that their child takes part in an activity.

Junior members who are under 16 years of age must be accompanied by a parent or guardian, or other adult acting in loco parentis, at all times.

Junior members aged 16 or 17 may take part in Club activities unaccompanied but a completed parental consent form must be completed and given to the trip leader before each trip.

Please do not hesitate to speak to the trip leader, or any of the Club's coaches, if you feel you need more information, or you are unhappy about any activity.
